I (the undersigned) understand and agree that there are inherent risks associated with dog training and the dog sport of lure coursing and that while engaged in any activity sponsored or operated by Leash on Life Illinois, Inc. ("Leash on Life") or its affiliates, including but not limited to, its officers, directors, members, guests, third-party trainers/educators, agents, property owners and their successors, agents and assigns, or any activity performed or held on the property located at 1378 Cherry Road, Oswego, Illinois, 60543 (the "George Property") or any property used by Leash on Life for an activity sponsored or operated by Leash on Life, I assume full responsibility and liability for those risks that may result in bodily injury, illness or damage, directly or indirectly, to myself, to my dog, to my property, or to any other object or being that I cause to be present at the activity. It is further understood that Leash on Life or its affiliates, including but not limited to, its officers, directors, guests, third-party trainers/educators, agents, property owners and their successors, agents and assigns, reserves the right to refuse any entry and to eject any person from any activity sponsored by Leash on Life or its affiliates, and/or the George Property or any property used by Leash on Life for an activity sponsored or operated by Leash on Life, for disorderly conduct, intoxication, or lack of control over a dog, or over any other object or being, caused by said person to be present at the activity, without refund of fees.

I understand and agree that I train and/or visit as a guest at any activity sponsored by Leash on Life or its affiliates, including but not limited to, its officers, directors, guests, third-party trainers/educators, agents, property owners and their successors, agents and assigns, or any activity performed or held on the George Property or any property used by Leash on Life for an activity sponsored or operated by Leash on Life, at my own risk. Furthermore, I assume full responsibility and liability for my actions, the actions of my dogs, and the actions of any other object or being that I cause to be present at any activity sponsored or operated by Leash on Life or its affiliates, should they result in any loss, damage, illness or injury to any other person, dog, or property.

I understand and agree that by signing this waiver and agreement to hold harmless, I, on my own behalf and on behalf of my successors, assigns, affiliates, attorneys, agents or representatives, relinquish all claims and agree to hold harmless Leash on Life and its affiliates, including but not limited to, its officers, directors, guests, third-party trainers/educators, agents, property owners and their successors, agents and assigns, from any and all claims, obligations, causes of action, suits, rights, debts, damages, liabilities, demands, expenses, fees and costs, or liability I ever had, now have, or may in the future claim to have, in law or in equity, anticipated or unanticipated, known or unknown, against Leash on Life and its affiliates, including, but not limited to, those which result from, or arise out of or otherwise relate directly or indirectly to any activity sponsored or operated by Leash on Life or its affiliates, including but not limited to, its officers, directors, guests, third-party trainers/educators, agents, property owners and their successors, agents and assigns, or any activity performed or held on the George Property.
